Report from Chair of the Board



Industry challenges

In my first report as Chairman last year I wrote that *"it would be hard to imagine a more difficult year for the aged care sector".* At that time I mentioned the challenges of:

• Unprecedented media scrutiny of the sector;

• The commencement of the Aged Care Royal Commission;

• Erosion of public confidence in the sector, through evidence brought before the Royal Commission;

• The Commencement of the Aged Care Quality and Safety Commission with its tougher regulatory approach; and

• The release of the new Aged Care Quality Standards.

This year, however, has been an even more difficult year for the aged care sector.

On top of the challenges of last year – most of which have continued this year the aged care sector has faced additional challenges from the COVID pandemic and worsening economic conditions.

The challenging economic conditions include low interest rates payable on Refundable Accommodation Deposits, and Government indexation of aged care funding not keeping up with increased costs.

Indeed, many commentators in the media have described the aged care sector as being in "crisis".

In addition to the sector-wide challenges, we also have some organisation-specific

challenges including:

- Aging facilities at Beth Eden and Janoah Gardens.
- Higher than desired vacancies at the Janoah Gardens retirement village.
- Maintaining our distinctive Christian ethos.
- A low profile in the community.

God's grace

God's people depend on His grace. At Bethany Christian Care, we depend on God's grace.

The Apostle Paul voiced this dependence when he wrote about a "thorn" in his flesh. He asked God three times to take the thorn away, but instead of removing the thorn God said 'My grace is sufficient for you, for my strength is made perfect in weakness.' (2 Corinthians 12:9).

God's grace is sufficient for us. As the beautiful hymn says, it is also amazing.

This year we have needed God's grace through times of uncertainty, confusion and limitation. I am pleased to be able to say that God's Grace has indeed been sufficient for Bethany Christian Care.

By His Grace...we have not had a COVID infection in residents or staff of our aged care facilities.

By His Grace...we have made a financial surplus.

By His Grace...we found and appointed a new CEO, Rohan Reid.

By His Grace...we passed an unannounced assessment contact (audit) from the Aged Care Quality and Safety Commission at The Plains aged care facility, meeting each of the assessed requirements.

By His Grace...we have seen God's presence, power and blessing among our staff and residents as we as we seek to honour Him in all we do.

While we acknowledge every good gift as coming from God's Grace, we also thank:

• Our dedicated staff - without them we would neither be delivering services nor engaging in Christian ministry;

• Our care management team – without the expertise of our care managers and their support personnel, we would lack the clinical leadership so necessary for quality care outcomes;

• Our executive leadership team - the leadership and direction of Acting CEO Michael Harding and new CEO Rohan Reid and the broader executive leadership team have been crucial;

• Our wonderful volunteers who "make a difference" enriching the lives of our residents and giving of their time and talents to assist in operational areas;

• Our residents and staff for choosing to be part of the Bethany Christian Care Family;

• Those who donate to our Pastoral Support Fund - the purpose of which is to financially support our pastoral and spiritual endeavours (gifts totalling \$8,566 were received during 2018/19, compared to \$5,860 last year);

• Former CEO and Executive Director Bruce Curtis who retired this year;

• Former Board members David McKee and John Melville (a former Board Chairman) who retired this year; and

• My fellow Board members.
